LICENCES

The Municipality of Sioux Lookout has no business licensing requirements. Generally, if the base of operations for the business is located within the boundaries of the Municipality of Sioux Lookout and the business (or landowner) will pay taxes to the Municipality, a Business License will not be required. However, you should check with the By-Law Enforcement Office if your business relates to the care of animals (Animal Control By-Law), taxi service (taxi licensing is required) or the burning of combustible materials (a burning permit is required). Certain permits are required for these types of operations.

OBTAINING REZONING

If a site is chosen for a proposed business that does not conform to the Zoning Bylaw or the Official Plan, an application may be made to the Municipality of Sioux Lookout for an amendment. An Amendment application form may be obtained from:

The fee for filing for rezoning is \$800.00 (By-law No. 06-18). An Official Plan Amendment Application fee is \$1000.00 (By-law No. 06-18).

OBTAINING A MINOR VARIANCE

To obtain a building permit to construct, renovate or alter a building, which does not exactly comply with the existing Zoning By-law requirements, a minor variance may be required. Minor variances are usually granted if the requested variance does not challenge the basic spirit and purpose of the Zoning By-Law and is distinctly "minor" in nature.

Application for a Minor Variance requires the completion of an Application form, a fee of \$400.00 (By-law No. 06-18) and copies of the proposed plan. Applications and further information can be obtained from:

LOCAL TAXES - MUNICIPAL ACCOMODATION TAX (MAT)

Any Fixed Roof Accommodation provider operating a transient accommodation (bookings of 30 days or less) within the boundaries of the Municipality of Sioux Lookout must be aware of the Municipal Accommodation Tax.

A Fixed Roof Accommodation provider is described as an owner/operator of a transient accommodation business that operates any of the following:

- Hotels
- Motels
- Bed & Breakfast establishment
- Airbnb establishment
- Hostels

The MAT came into full effect on January 1, 2020 at a rate of four percent (4%) as approved by Sioux Lookout Council and authorized as per section 400.1 of the Municipal Act, 2001 and Ontario Regulation 435/17.

Companies Branch registers business names of sole proprietorships, partnerships and corporations; authorizes creation of limited partnerships; incorporates business and not-for-profit entities and licenses foreign extra- provincial corporations. The branch also maintains and operates the Public Record, which is searched regularly by clients. Ontario Business Connects provides electronic registration for business names, and primary service providers OnCorp Direct Inc. and Cyberbahn Inc. provide searches electronically.

Services Offered to the Public:

Search for Business Names that have been registered

• Register or renew your Business Name, get a Master Business License and, if eligible, apply for additional accounts with different government bodies

New businesses and existing corporations can prepare their registrations using these workstations and electronically transmit them to the different ministries involved with starting or expanding a business. Individuals starting an incorporated business can register their Business Name instantly and complete three of the most commonly required applications (Employer Health Tax, Health Tax for the Self- Employed and Workplace Safety and Insurance Board) at the workstations. Clients can instantly renew their Business Name registration and apply for the Federal Business Number.

FOOD PREMISES

All businesses in Ontario engaged in the preparation or serving of food must comply with Ontario regulations. It is the responsibility of Health Units to provide health inspectors to carry out inspections to ensure that these Provincial Standards are met.

OCCUPATIONAL HEALTH

The Occupational Health and Safety Act applies to all workers and work places in Ontario with a few exceptions. It involves the responsibilities of employers, supervisors, workers and suppliers with regard to occupational health and safety. The Act also covers the establishment of joint labour and management health and safety

committees; the control of the exposure of workers to toxic substances; refusals to work where health or safety is in danger, and reporting of accidents.

TAXES

HARMONIZED SALES TAX

As of July 1, 2010, Ontario harmonized its retail sales tax with the GST to implement the HST at the rate of 13%.

Almost everyone has to pay HST on purchases of taxable supplies of property and services. A limited number of sales or supplies are exempt from HST such as used residential housing, most health care and dental services, certain childcare services, and many educational services.

Although the consumer pays the tax, businesses are generally responsible for collecting and remitting it to the government. Businesses that are required to have a GST/HST registration number are called registrants.

Registrants collect the GST/HST on most of their sales and pay the GST/HST on most purchases they make to operate their business. They can claim an input tax credit, to recover the GST/HST paid or payable on the purchases they use in their commercial activities.

GST/HST registrants must meet certain responsibilities. Generally, they must file returns on a regular basis, collect the tax on taxable supplies they make in Canada, and remit any resulting net tax owing.

HARMONIZED SALES TAX -- REMITTANCE

Every business with annual revenues of goods and services of more than \$ 30,000 is required to be registered. Businesses registered for the HST are eligible to claim an Input Tax Credit for the HST paid on business purchases. The credit is applied against

the HST charged on sales to determine whether tax should be remitted or a refund claimed.

If both an excise tax and the HST are applicable, the excise tax is applied before the HST.

FEDERAL REGULATIONS AND TAXES

INCORPORATION

If a corporation intends to have branch operations in more than one province it may be advantageous to procure Federal incorporation. A corporation must be registered in each province in which it does business. Check with each province for further details.

For Federal incorporation there is a flat fee of \$ 500. Articles are filed with:

STARTER COMPANY PLUS

Starter Company Plus is a Government of Ontario funded program designed to create sustainable jobs for its residents through entrepreneurship. The program is open to those looking to purchase, expand, or open a new business.

Through Starter Company Plus participants will receive one-on-one business training, business plan development, mentorship and the chance to receive funds for their venture of up to \$5,000.

How it Works

Starter Company is a training program for enterprising young people between the ages of 18-29 who to start, buy, or expand a business in their community. The program will provide training sessions on aspects of running a successful business;

mentorship from local business up and running; as well as gain additional experience running a successful business that may help you obtain more traditional financing such as bank loan if you so require in the future.

Successful applicants nay then apply for the Starter Company Grant to receive up to \$5,000 to kick off a new business or expand your current business and successful applicants must provide matching funds worth 25% (in cash or equivalent) of the grant.

You are eligible for Starter Company Plus if you are:

- 18 years of age or older
- An Ontario resident and Canadian citizen (or permanent resident)
- Not attending school full-time or returning to school
- Starting, expanding or buying a small business
- To qualify for a grant, you must be able to make a contribution to your business in cash or in kind, it has to be equivalent to at least 25% of the grant amount
- Prepared to complete the business training components of the Starter Company Plus program as prescribed by the Small Business Centre as the Program Provider
